Overview

John Goldsmith is a shareholder in the firm's Litigation and Dispute Resolution Group. He practices complex litigation including constitutional torts (civil rights such as 1981 and 1983 claims), employment discrimination and related claims, antitrust, intellectual property, products liability, class actions, health care, and Multi District Litigation (MDL). He tried to verdict multiple constitutional tort, discrimination, anti-competition, intellectual property, contract and tort claims. John has represented Fortune 100 companies, mid-size companies, small start-ups, individuals, cities, school boards, universities, and other governmental entities. He represents a wide variety of participants in the health care industry, including insurers, physicians, medical product and drug manufacturers, bond holders, and medical practices in a wide range of litigation, administrative proceedings and bankruptcy. He has also been involved in defending class actions in MDL litigation. John has had considerable success in managing MDL defense litigation and opposing class certification, including arguing for the application of the federal Class Action Fairness Act (CAFA) and various immunities available to defendants in certain industries.

- Successfully defended a group of 16 chiropractors, clinics, and medical doctors who were sued by an insurance company for fraud, civil conspiracy, unjust enrichment, FDUPTA and declaratory judgment, alleging medically unnecessary treatment of over 1,000 patients over 6 years. The jury returned a 100% defense verdict after a 3 week trial.
