### Overview

### Representative Matters

- Secured complete defense verdict in a three-week federal jury trial representing 16 healthcare providers in a lawsuit brought by State Farm alleging fraud, civil conspiracy, unjust enrichment, and violations of Florida's Deceptive and Unfair Trade Practices Act.
- Obtained final summary judgment for a local religious organization in a federal lawsuit brought by a national software company alleging copyright infringement and breach of a license agreement.
- Achieved preliminary and permanent injunctive relief for a multi-national electrical subcontractor against a former vice president for violating non-compete, non-solicitation, and confidentiality agreements.
